The treatment effected

The treatment will only concern navigation data, and is effected for statistical purposes and to verify the correct function of the site and its security, and not for purposes of any direct identification of the visitors.

The statistical analysis of the navigation data is effected through the Google Analytics web analysis service supplied by Google, Inc. (“Google”), the data collection and treatment method of which is defined at this address and provided (in abridged form) below:

“Google Analytics is a free analysis instrument provided by Google, which enables the owners of websites to understand how visitors are attracted to their website. Google Analytics collects data in an anonymous manner and, similarly to the examination of footprints on the sand, indicates the trends of websites without identifying the individual visitors. Google Analytics uses its cookies to control the interactions of the visitors. Cookies are used to memorize information such as, for instance, the hour of the current visit, if the visitor has already visited the site in the past and what site has directed him to the web page. The clients of Google Analytics may visualize a wide range of reports on the manner in which the visitors interact with their website, in order to be able to improve the website and the manner in which the visitors reach it. A different cookie is used for every website, and the visitors are not monitored on several sites.”

Any refusal to use cookies, by selecting the specific settings on your browser, may make it impossible to use all the functions of this website.
